### **Al Condeluci, PhD**

Dr. Al Condeluci has been a leader in community building, human services and inclusive advocacy work for the past 50 years. Holding a PhD and MSW from the University of Pittsburgh, Dr. Condeluci has been the CEO of CLASS (Community Living and Support Services) a major nonprofit, community building organization in Pittsburgh, PA from 1973 to 2019. He holds faculty status at the University of Pittsburgh in the Schools of Social Work, and Health, Rehab Sciences and is author of 7 books including the acclaimed, Interdependence: The Route to Community (1995) and Social Capital: The Key to Macro Change (2014). In 2018, he received the "Key to the City of Pittsburgh," the highest civilian honor that can be given to a community member. He serves as a consultant, advisor, and human service coach and is on a number of nonprofit boards and government commissions on state, local and national levels. He helped found, and convenes the Interdependence Network, an international coalition of professionals, family members, and consumers interested in community engagement and macro change.



### **Gordon Horn, PhD**

**Thomas Whittaker, MD, JD**

Dr. Whittaker is a Board-Certified Neuro-Ophthalmologist and one of the few in Kansas and Missouri. Dr. Whittaker earned his MS in Biomedical Engineering from Marquette University, Milwaukee, WI. He received his J.D. with distinction from the University of Missouri-Kansas City School of Law and his M.D. from the University of Kansas School of Medicine, Kansas City, KS. His internship and ophthalmology residency were completed at the University of Missouri-Kansas City School of Medicine and his neuro-ophthalmology fellowship was at the Dean McGee Eye Institute at the University of Oklahoma. He was Director of our Residency Program from 2005 until 2021, when he stepped down and is now Associate Director of the program. ### **Blake Lehmkuhl**

On November 7, 2015, Blake, who was 11 years-old, was involved in a boating accident while at the Lake of the Ozarks. Blake suffered a severe traumatic brain injury, and was life-flighted to University Hospital in Columbia, MO. After spending 2 weeks on the ICU floor in Columbia, he was transferred by ambulance to Children's Mercy Hospital in Kansas City, where he spent another 7 weeks in-patient on the rehabilitation floor. It was at Children's Mercy that Blake's family began to understand the severity of his injuries. Blake had to relearn everything from how to swallow to how to walk and everything in between. Since being discharged from the hospital, Blake has participated in thousands of hours of physical, occupational, and speech therapies. He has recovered physically and cognitively more than was originally thought possible, and he has continued to see improvements well past the original 2-year timeline his family was given. He believes that this is in large part due to the excellent medical care he has received, in combination with the work of the amazing therapists he has worked with in the past and continues to work with today. Blake has experienced first-hand how the lack of education surrounding traumatic brain injury affects survivors, and he feels that public speaking is one way that he can raise awareness and be a voice for those survivors who cannot speak for themselves. Blake graduated this year from Olathe Northwest High School and will be attending Johnson County Community College in the fall. No relevant financial or nonfinancial relationship exists.

### **Tyler Moss**

A member of the Kansas City, MO police department, Tyler was shot in the head in July 2020 at a restaurant when he and his partner confronted an individual waving a gun. He was in a coma for more than 2 weeks and spent several more weeks at a rehabilitation hospital in Colorado. He continues to work at getting better and has resumed some part-time duties with the police department. He views each day as a gift. "I appreciate things a lot more. I'm very thankful for life in general. I don't take things for granted anymore." Tyler also has a message for those fighting through hard times, "Just keep your head up and if you're going through a struggling time, where things are hard, keep pushing through and things will come around." 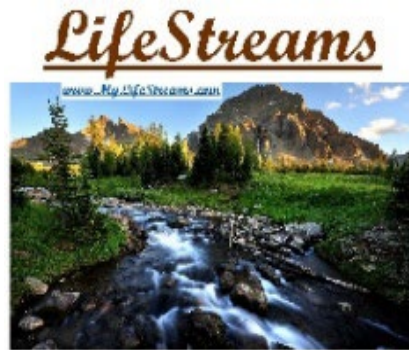
