Gary Berger Memorial Lecture



Alexandra Arickx, MD

Dr. Alexandra Arickx is a board-certified physiatrist with sub-specialty board certification in Brain Injury Medicine who focuses on brain injury rehabilitation in the inpatient rehabilitation and outpatient healthcare settings. She completed residency training in Physical Medicine & Rehabilitation (PM&R) at the Ohio State University Wexner Medical Center and fellowship training in Brain Injury Medicine at New York University Langone Health, Rusk Rehabilitation. She is an assistant professor at the University of Kansas Medical Center where she serves as the associate program director for the PM&R residency program and medical director for brain injury within the Department of Physical Medicine & Rehabilitation. Jerry Hoepner, PhD, CCC-SLP

Dr. Hoepner is the co-author of the textbooks "Clinical Neuroscience for Communication Disorders: Neuroanatomy and Neurophysiology" and "Acquired Neurogenic Communication & Swallowing Disorders: An integrated clinical approach" by Plural Publishing and author of the text, "Counseling and Motivational Interviewing in Speech-Language Pathology" by Slack Publishing. His poetry group recently published, "I don't think I did this right", a collection of poems by people with brain injuries and aphasia. Eliyas Jeffay, PhD, C.Psych

Dr. Eliyas Jeffay received his Honors B.Sc., M.A., and Ph.D. degrees from the University of Toronto. He is an early-career Clinical Neuropsychologist in the Brain Discovery and Recovery Research Program at the Toronto Rehabilitation Institute. He conducts clinical assessments, provides interventions, and engages in research related to the rehabilitation of individuals after acquired brain injury. His research interests include exploring physical exercise, behavioral therapies, and new technologies to advance clinical neuropsychological assessment and treatment, as well as the ecological validity of neuropsychological assessment. His doctoral dissertation involved developing and validating an ecologically valid virtual reality measure for patients who were in the post-acute phase after sustaining a mild traumatic brain injury. His current work involves validating a novel allocentric visuospatial navigation intervention using Google Street View, which indirectly stimulates the hippocampi to ultimately reduce atrophy due to neurodegenerative processes following moderate to severe traumatic brain injury. He is the lead author of the Executive Functions rehabilitation clinical guidelines published in the Journal of Head Trauma and Rehabilitation special series INCOG 2.0 Guidelines for Cognitive Rehabilitation Following Traumatic Brain Injury. Today, Dr. Komm uses meditation, breathwork, EMDR, and modified yoga to help with her symptoms. She is on track to complete the LoveYourBrain Level 2 Yoga & Facilitation Training. 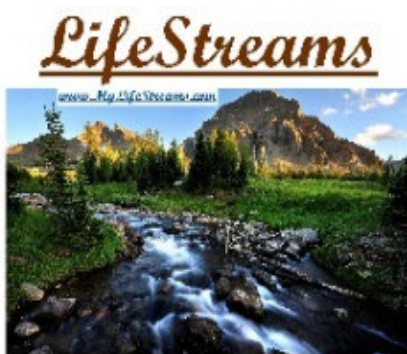
