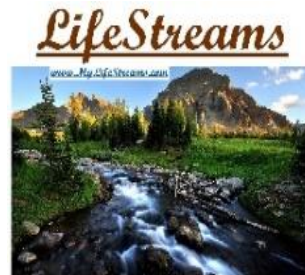

Keynote Speaker



Patrick Armistead-Jehle, PhD., ABPP-CN

Dr. Armistead-Jehle, PhD, ABPP-CN, is the Chief of the Concussion Clinic at Munson Army Health Center, Fort Leavenworth, Kansas. He earned his PhD in Clinical Psychology from Virginia Commonwealth University and completed his doctoral training at Tripler Army Medical Center. He then served as an Active-Duty Army Psychologist prior to working as a clinical neuropsychologist for the Department of Veterans Affairs, in Honolulu, Hawaii.

Since 2009 he has been active in clinical and research activities at Munson Army Health Center. Dr. Armistead-Jehle has authored over 50 journal publications and over a dozen book chapters, largely focusing on neuropsychology testing and TBI. He has given several presentations at national neuropsychological and psychological conferences.

Dr. Armistead-Jehle is a Licensed Psychologist, who is certified by the American Board of Professional Psychology in Clinical Neuropsychology. Dr. Armistead-Jehle serves as an assistant editor for three peer reviewed journals and is an ad hoc reviewer for over a dozen others. He is a member of American Academy of Clinical Neuropsychology and a Fellow of the National Academy of Neuropsychology.

Janet M. Williams, MSW, PhD

Dr. Janet Williams has been an advocate since birth. As the youngest of 5 in a huge Irish family she pretty much had to stomp her foot to be heard and seen. Over the years she has refined (mostly) and used those skills to become an advocate for the full inclusion of people into the community and society. Her unwavering commitment revolves around supporting people with brain injuries and families to become self-advocates.

Dr. Williams has written a number of journal articles and a few books, including co-editor of "Head Injury a Family Matter" (1991) and "Children with Acquired Brain Injury: Educating and supporting families" (1996). She has traveled to all 50 states, and several countries including Denmark, The Netherlands, Germany, Italy, Kenya, and India where she conducted comprehensive studies on rehabilitation systems for individuals with brain injuries.

Janet founded communityworks, inc and Minds Matter LLC, both community-based organizations providing comprehensive services to those who need them. She earned a BA from Providence College, an MSW from Boston College and a PhD from The University of Kansas.

Joanne Gold, PharmD

Dr. Joanne Gold is a board-certified clinical pharmacist who has worked in numerous pharmacy settings, including 6 years in the Air Force, where she conducted medication therapy management and developed a special interest in improving the management of mTBI and psychological health conditions in service members and veterans. 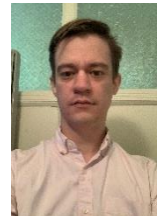


Lisa Stalp, PhD

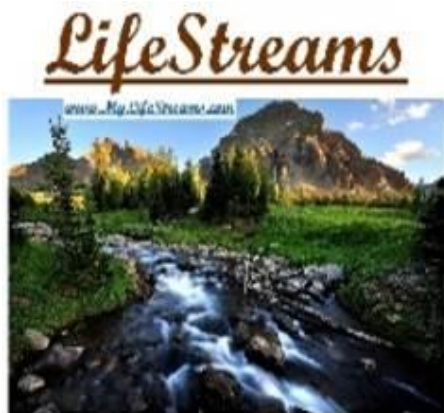
